## September 23, 2021 Meeting Minutes

- 4. Old business
  - A. Approve meeting minutes of August 26, 2021

Amend minutes to change "appalled" to "disappointed". Motion: Gustin, second Calder, approved.

- 5. New Business
  - A. Housing Density Discussion

Sichel introduced the topic of housing density limits in the current zoning ordinance. Shatney noted that there is interest in developing an area off of Prospect Street but their plans to not fit within the current R-4 zoning. Shatney also stated that several attempts to find funding to develop the Ward 5 School but did not lead to anything.

There was some discussion of what the problems facing developers are and whether any changes are needed. There was discussion of the balance of infrastructure costs against property tax revenue. Shatney informed the Commission that a developer on Prospect Street was interested in pursuing a special assessment district and public bond financing to pay for infrastructure construction.

Gustin asked to follow up to get more information on the limitations for Ward 5 School development. Hellein said he would provide a motion at a future meeting recommending to remove minimum parking requirements and reform the winter parking ban.

### 6. Staff Updates

Shatney said 5-6 sales a week are being recorded. There's a development creating upper-story housing on Main Street.

Shatney mentioned that the Planning Commission is planning to meet with the TAC and PRC Committees in the future.

#### 7. Roundtable

Hellein mentioned he noticed that vinyl does appear to be a permitted material for window signs in the current ordinance, and only pre-cut letters are prohibited.

Gustin noted that she and Sichel will be attending the upcoming Council meeting.

Anthony noted that it's not the Planning Commission's role to specify whether owner-occupied or renters are preferred, but would really like to see more people invested in the community through owning their homes.

## **G**LOSSARY

Minority- or Women-Owned Business Enterprise (M/WBE): Businesses that are at least 51% owned and substantially managed by people of color and/or people identifying as women

**Disadvantaged Business Enterprise (DBE)**: As defined by the U.S. Department of Transportation, DBEs are "for-profit small business concerns where socially and economically disadvantaged individuals own at least a 51% interest and also control management and daily business operations. African Americans, Hispanics, Native Americans, Asian-Pacific and Subcontinent Asian Americans, and women are presumed to be socially and economically disadvantaged. Other individuals can also qualify as socially and economically disadvantaged[...]"

Marginalized population/group: Communities or groups that have historically experienced systemic barriers to access, resources and infrastructure investments. It may include communities of color, women, sexual orientation, transgender individuals who identify along the gender spectrum, immigrants and refugees, people with disabilities and others who have received limited access to benefits, services, investments and resources from public/private institutions, including the State of Vermont.

**Equity**: The condition that would be achieved when a person's race or other demographic group membership is no longer predictive of that person's life outcome.

Staff Updates for week ending October 25, 2021:

- 1. Masks continue to be required to enter any city building (City Hall, Alumni Hall, Aud, etc.)
- 2. VCRD (Vermont Council on Rural Development) Step 3 occurred virtually and in person on October 20. Commissioner Sichel will give an update under the agenda item, and speak about the Housing Task Force, one of the 3 priority projects that were chosen at the September Step 2 meeting.
- 3. The Assessing Clerk processed 21 PTTR's (Property Transfer Tax Returns) in the last 2 weeks. Remember, PTTR's come in not only for sales of homes, but transfers into life estates, etc.
- 4. Development applications these last two weeks included electrical applications, and permit applications for a kitchen replacement, installation of a mobile home on vacant property on Foster Street, a replacement sign for Central Vermont Adult Basic Education, and the required zoning permit for the Recovery Residence project on Keith Avenue that accompanies the DRB Decision, were issued.
- 5. FEMA hosted a mapping project for the Winooski Watershed that I participated in.
- 6. Habitat for Humanity's Project at 11 Highland Avenue is under way, and there is a work party Saturday, October 23 which people can volunteer to help.
- 7. St. Monica's has called regarding their 10 West Street property, that they want to remove the remaining foundational supports and continue to use as a parking lot for the school.
- 8. Washington County Mental Health Services purchased the former Fortier Care Home at 127 Bailey Street at the end of September, and they are applying to re-certify the home and get it back open under their ownership.
- 9. I intend to work on the zoning sign work next week to have something for review in November my bandwidth remains minimal, and those items daily that require immediate attention become my priority.
- 10. We have 3 holidays in November and December, and need to discuss meeting dates. Chair Sichel will address under the agenda item, and a calendar showing city meetings is attached. Thursday November 11 (Veterans Day City Hall is closed) and Thursday November 25 (Thanksgiving City Hall is closed) are our standing November meeting dates. Thursday December 23is our standing meeting date, and city hall is closed Friday the 24<sup>th</sup>.
