In connection the Entertainment License request, the following additional conditions are attached to the license and must be adhered to:

1. All entertainment must be conducted in accordance with established Fire Codes and Tickets may not be sold in excess of maximum seating capacity.
2. A minimum separation of three (3) feet must be maintained between performer and audience/attendee/patron during any performance of other entertainment that involves nudity.

All annual Entertainment Licenses expire at midnight on the 31st of December of the license year and Single Event Licenses expire at conclusion of the event unless otherwise revoked earlier pursuant to City of Barre Ordinances, Chapter 11, Section 11-33.
