Five-thousand-dollar line-item exceedance will be taken from the Hazardous Tree removal line item. The Purchase and Sales Agreement was discussed with the City Attorney on February 15th.

RFP for trail, bridge and Trail Assessment: RFP was posted and Apex TrailWorks bid was accepted. Work is anticipated to be completed this summer.

Tools: Jim will proceed with the purchase of the trail tools outlined in the ERSA Grant.

<u>ERSA Sub-Committee</u>: The sub-committee will draft a contract for Apex Trailworks and will be proactive in assisting the City in obtaining a State permit for the construction of the bridge, if required.
