SUMMARY OF INCIDENT:			
On February 8, 2018 at approximately 1849 hours, Barre City Officers responded to Jerry's Sports Bar in Barre, Vermont for a report of a physical altercation in the parking lot between a man and woman . On arrival officers investigated the incident and discovered that Douglas Crowningshield had struck a woman in the face after a verbal altercation with several other people at the bar. Crowningshield was also discovered to be violating active court conditions stating that he could not act in a violent or threatening manner nor drink alcoholic beverages to the extent that they interfere with his welfare or others. Officers attempted to arrest Crowningshield at this time but he resisted their efforts and also assaulted an Officer . Crowningshield was eventually arrested where he was lodged at the Barre City Police Department for lack of \$2,500 bail. Crowningshield is due to appear at the Washington County Superior Court on February 9, 2018 at 1230 hours.
