### SUMMARY OF INCIDENT:

The narcotics were identified as belonging to two of the passengers in the vehicle, Zackery Rillo and Nichole LeClair. A warrant for the arrests of Rillo and LeClair was requested and submitted to the Washington County Superior Court.
