The fees assessed for electrical work are set forth in City Ordinance Chapter 5, Section 5-5, along with the Fee Schedule as adopted by the City Council.

There is a minimum fee of \$125.00 for the first re-inspection for any permit.

There is a minimum fee of \$200.00 for the second re-inspection plus any additional re-inspections for any permit.

Payment must be included at the time of submission.

Fire Alarm Installation requires a plan review submittal, building permit application and fee, prior to installation.

Solar Panel Installation requires an electrical permit to include: solar panels, sub-panels, solar combiner/inverters, lights/outlets/switches, stationary appliances and the base fee. It must also include a building permit application with fee.

If work has begun prior to receiving a permit(s), you are in violation of City Ordinance and are required to pay \$150 in addition to the subtotal fee calculated at left.
