SUMMARY OF INCIDENT: On May 6, 2026, at approximately 8:30 PM Barre City officers with assistance from Barre Town Police and VT Department of Corrections executed a search warrant for narcotics and evidence of sales of narcotics at a residence along the unit block of Allen Street in Barre City. As a result, officers seized approximately 582 grams of crack cocaine, 9.89 grams of fentanyl, a large amount of suspected LSD blotter sheets, two semi-automatic handguns, and \$21,324 in US Currency. In total, six (6) arrests were made.

20-year-old Julian Henderson of Manchester, CT was lodged at the Northeast Correctional Center in lieu of \$1 million dollars bail and is due to appear in Washington Superior Court on May 7, 2026, at 12:30 PM to answer the charges of Conspiracy, Cocaine Trafficking, Use of a Firearm while Dispensing/Selling, Fentanyl Trafficking, and Possession of LSD.

20-year-old Tayshaun Parkman of Manchester, CT was lodged at the Northeast Correctional Center in lieu of \$1 million dollars bail and is due to appear in Washington Superior Court on May 7, 2026, at 12:30 PM to answer the charges of Conspiracy, Cocaine Trafficking, Use of a Firearm while Dispensing/Selling, Fentanyl Trafficking, False Info to Police, and Possession of LSD.

31-year-old Amber Hussey of Barre, VT was lodged at the Chittenden Correctional Center in lieu of \$100 bail on an arrest warrant.

62-year-old Jean Zampieri (homeowner) of Barre was cited to appear in Washington Superior Court at a later date to answer the charge of Dispensing from a Dwelling.

39-year-old Dustin Boyce of Williamston was cited to appear in Washington Superior Court at a later date to answer the charge of Possession of Cocaine.

35-year-old Brittany McAdams of Barre was cited to appear in Washington Superior Court at a later date to answer the charge of Possession of Cocaine.
