Green-Up Day - May 4th

 participate in Green-up Day.

- Invasive removal Continuation of 2017-2018 efforts will be the focus. Mike Perrigo will secure the Sno-Bees ATV to assist with the removal of materials. A PullerBear tree and root puller will be purchased with Semprebon Funds. Chris will consult with Carol Dawes on the purchase.
- Pine Tree removal- The Pine trees in the areas brush-hogged in 2018 will be removed. VYCC youth
 are unable to use power tools and could not complete this portion of the meadow restoration
 project.

Cow Pasture Entrance Improvements:

- The Committee revisited the project design and goals. The option of placing rocks with an opening that would allow brush hog entry without placing concrete barriers was discussed. A design that allowed for additional parking is desirable.
- Chris will request an on-site meeting with Bill Ahearn and asks that Committee members attend.

YYCC 2019 Projects:

- Committee was unanimous in support of requesting VYCC to restore the water-bar that was
 widened to standards of a Class 4 road and install the priority water-bar that was requested at the
 stream crossing and not installed. The projects will be separate from 2019 funded work and can
 be completed prior to July 1, 2019 when funds are available for this year. Chris will contact VYCC
 to discuss.
