Bill Ahearn noted the example of the relocation of the sidewalk and bus stop at North Main St and Beckley St. Where he wishes to reallocate the accessibility feature towards North Seminary St to resolve some traffic and safety issues. Bill Ahearn notes that a preliminary plan will be in place before winter.
- iv. Bill Ahearn notes that he is planning on getting a preliminary plan for Quinlan Dr and Sheridan St. Which will entail closing Midway, and constructing a new road at Sheridan to Quinlan.
